UPON the Application of the Plaintiff/Applicant, Assadi Private Capital, Inc. (“Assadi”) (the “Application”) for summary judgment against the Defendants/Respondents, The Beet Performance Nutrition Inc., Michele Anne Helmeczi, and Nickalas Leslie Blevins (collectively, the “Defendants”); AND UPON having read the Application, the Affidavit of Alexis Shahriar Assadi, affirmed on February 9, 2022, filed, and the pleadings in the within Action, filed; AND UPON hearing from counsel for the Applicant and any other party present; AND UPON having considered Rule 7.3 of the *Alberta Rules of Court*, Alta Reg 124/2010,

AND UPON NOTING THAT NO ONE APPEARED FOR THE DEFENDANTS DESPITE BEING SERVED;

**IT IS HEREBY ORDERED AND DECLARED THAT:**

1. Service of the within Application and supporting materials is hereby deemed good and sufficient, and the Application is properly returnable before the Court as against each of the Defendants;
2. Assadi is hereby granted summary judgment against the Defendants, The Beet Performance Nutrition Inc., Michele Anne Helmeczi and Nickalas Leslie Blevins, jointly and severally, in the amount of \$17,757 pursuant to the terms of the Replacement Loan Agreement between the parties dated October 22, 2019 (the “**Agreement**”);
3. Assadi is granted post-judgment interest on the full amount of judgment outstanding in this Order in accordance with the *Judgment Interest Act*, RSA 2000, c J-1, from the date of this Order, until payment of the full amount of judgment in this Order is made; and
4. Assadi is awarded solicitor-and-own client, full indemnity costs, in accordance with the Agreement, in an amount of \$5000.00.
